**ANN FLORINI** is visiting professor and director, Centre on Asia and Globalization, Lee Kuan Yew School of Public Policy, National University of Singapore, and Senior Fellow at the Brookings Institution in Washington, DC. He is a graduate of Harvard University, and a founding editorial board member of freedominfo. org, a virtual network on international freedom of information.

**RICHARD CALLAND** is the Executive Director of the Open Democracy Advice Centre (ODAC) in Cape Town and a founding member of the law

center, formed in 2000. He is also head of the Right to Know program at the democracy think tank Idasa. Prior to joining Idasa in 1995, he practiced law at the London Bar for seven years, specializing in human rights law. He holds postgraduate degrees in world politics and comparative constitutional law (LLM) from the London School of Economics and the University of Cape Town respectively. He has published extensively on the politics of the South African transition and is a political columnist for the Mail & Guardian newspaper. His most recent book, Anatomy of South Africa: Who Holds the Power? was published in October 2006.

JAMIE P. HORSLEY is Deputy Director of The China Law Center and lecturer in law at Yale Law School. She has been the managing partner of the China offices of Paul, Weiss, Rifkind, Wharton & Garrison; commercial attaché in the U.S. embassies in Beijing and Manila; Vice President of Motorola International, Inc. and Director of Government Relations for China for Motorola, Inc.; and a consultant to The Carter Center on village elections in China. SHEKHAR SINGH is founding member and former convenor, National Campaign for People's Right to Information in India, and former director of the Centre for Equity Studies, New Delhi. He has taught at the Indian Institute of Public Administration, New Delhi, the North-Eastern Hill University, Shillong, and St. Stephen's College, University of Delhi. He has been advisor to the Planning Commission of India and has been associated with a variety of nongovernmental organizations and popular movements. His publications include: Large Dams in India: Environmental, Social and Economic Impacts (2002); Setting Biodiversity Conservation Priorities for India (2000); and Strengthening Conservation Cultures (2000).

**IVAN SZEKELY** is Counsellor, Open Society Archives at Central European University and associate professor at the Budapest University of Technology and Economics (BUTE). He has written some thirty major studies on the theoretical and practical aspects of openness and secrecy, including conducting the first Hungarian research on data protection and information privacy (1989–1990) and coauthoring both the Hungarian National Information Strategy (1995) and the government's theses on the information society (2000). He has helped to create numerous institutions in Central and Eastern Europe on data protection, freedom of information, and archives. In 1994, he prepared a multidisciplinary doctoral thesis at the Faculty of Natural and Social Sciences of BUTE (information management); he defended his second thesis for candidacy (sociology) in 1998.

HANHUA ZHOU is a Professor of Law and the Director for Constitutional and Administrative Law Division in the Institute of Law, Chinese Academy of Social Sciences. He was also one of the founders and serves as vice chairman in the China Information Law Society. As a member of the Advisory Committee for State Informatization and the State Advisory Committee for Cutting the Red Tape, and as advisory expert for several other governmental agencies, Dr. Zhou has been involving in cutting-edge research and decision-making process in connection with freedom of information and regulatory reform for some time, including leading the first task force on freedom of information research in China, drafting the Freedom of Information Regulations for the government, and taking part in drafting the Administrative License Law organized by the State Council Legal Affairs Office. Dr. Zhou was a senior visiting scholar at Yale Law School from September to December 2000, a visiting scholar in the Norwegian Institute of Human Rights from July to December 1998, and a visiting scholar at University of Michigan Law School from 1993 to 1995. From 1997 to 1999, Dr. Zhou practiced law in the Beijing Jun He Law Offices.
